**FORMS FOR CERTIFICATE ON ORIGIN OF GOODS AND APPLICATION FOR ISSUING
CERTIFICATE ON GOODS' ORIGIN**

The forms have dimensions 210 × 297 mm. Tolerance per length is minus 5 mm, that is, plus 8 mm. Print is on white, wood-free writing paper, which must have at least 64 grams per square meter. The back must be with printed with a coffee-black layout "guilloche", so that any forgery with mechanical or chemical means can be noticed.

Montenegrin authorities in charge retain the right to print the forms themselves, or to order their printing from authorized printing houses. In the latter case, each form must refer to such authorization. On each form the name and address of the printer, or a mark enabling its identification must be quoted. The form must have a serial number, printed or imprinted, enabling its identification.

**RULES THAT SHOULD BE RESPECTED DURING COMPLETION OF THE FORM FOR
CERTIFICATE AND APPLICATION FOR ISSUING A CERTIFICATE ON THE ORIGIN OF
GOODS**

1. The forms must be completed with a typewriter, computer or in exceptional cases, by hand. As a rule, they should be completed in Serbian, except if due to the need of commerce it is necessary to use another language. If the forms have been completed in hand, they must be completed in ink and in printed letters.
 2. Certificate and application for issuing of certificate must not contain errors or corrections written across the basic text. Amendments are done in such a way as to strikethrough the wrong citation and next to it correct citation shall be added. Every such amendment should be confirmed by the person who has performed the amendment, and it shall be subsequently confirmed by the authority in charge.
 3. Every item from box 6. quoted in the application and certificate must have an ordinal number. The last item must be underlined with horizontal line. One should cross the empty space by diagonal lines, so that the unused space must not be used for additional entries.
 4. If the conditions of sales and purchase so require, one or more additional copies of the certificate on origin of goods can be issued.
