GENERAL NOTES

1. The model outlook is not compulsory; e.g. the customs authorities may decide to use lines, instead of fields, in the form, or they may want to consider expanding them.

However, the ordinal numbers and their corresponding text are compulsory.

2. The customs authorities may decide to insert additional fields or lines. These fields and lines shall be marked with an ordinal number and a capital letter (e.g. 5A).
3. In principle, fields with ordinal numbers in bold must be filled. The explanations refer to the exceptions.
4. The addendum to this Annex contains codes for economic conditions used in inward processing.
